B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

F-1 Sept. 17, 1964 - Arthur O. Enger. RLS recovered pipe set by Carl Christensen, presumably from original bearing trees or personal knowledge of corner's history. Road construction has destroyed any evidence of BT's. Corner seems to check well with natural features and other corners eastward along the township line.

Nov. 24, 1993 - Thomas P.O'Brien, PS recovered Carl Christensen monument.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

F-1 2" iron pipe w/2 1/2" brass cap stamped "33-1/4-4, C.C."
16" Jack Pine N22 1/2W 96 1/2 links (63.69') Enger witness.
