A. Description of original monument and accessories and/or subsequent restoration:

M-1 (N.E. Corner Sec. 1)
Sept. 11/50 Algernon Merryweather D.S. set T. Corner between 42&43 North,
Range 15 West.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

M-1 May 23, 1961- Billy D. Buckler, RLS set a 1" pipe with brass cap at the Township corner (Towns 42-42 North and Range 15 West.) Corner was re-established using section corners 1 mile South; 1 mile East; 1 mile West and 6 miles North."

April 2, 1996- Thomas P. O'Brien P.S., recovered a 1" pipe with 4" brass cap as set by Billy D. Buckler on May 23, 1961.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

M-1 Found Mich. Dept. of Cons. 1" pipe with 4" brass cap stamped to identify.
