A. Description of original monument and accessories and/or subsequent restoration:

(8-Sec. 12) Center-West 1/16 corner, Section 12. Not previously monumented.

(11-Sec. 12) Southwest 1/16 corner, Section 12. Not previously monumented.



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(8-Sec. 12) Established the position for the corner midway and on a straight line between Quarter
corner 1337.29' west and the intersection of 1/4 lines of Section 12, 1337.29' east.

(11-Sec. 12) Established the position for the corner at the intersection of straight lines
connecting opposite 1/16 corners.
