Hemlock 17" S42W 24 links, Hemlock 22" N58W 17 links. 1960 Reestablished by Billy D. Buckler RLS midway and on line between Section corners. Set 1" iron pipe with 4" brass cap. 12" Soft Maple S60E 32.5 links, 18" W.Pine S58W 47 links.
- (14-Sec. 21) South 1/16 corner between Sections 21 and 22. Not established in the original survey.
