Original monument and accessories have been obliterated. Found R.R. spike as referenced in no.'s 3, 4 and 5 above just below P.K. and tag #24622 as referenced in no.'s 10 and 11 above. Distance between this location and K-12 is in close accord with the distance shown in Ezra L. Mason's survey Book B, page 91, January 1861 (Mason 39.65 chains, 2616.9 feet) vs. (2616.34 EDM). Accepted this position as the best available evidence of the original corner location. Excavation for Harrison marker provided no further evidence.
